WHEREAS, Calumet Downs Subdivision, being a subdivision in the North East One-quarter (NE $\frac{1}{4}$) of Section Seventeen (17), Town Eight (8) North, Range Twenty-two (22) East in the Village of Fox Point, Milwaukee County, Wisconsin, established on the north thereof a thirty (30) foot road known as Dunwood Road, and

WHEREAS, at the time of the platting of said Calumet Downs Subdivision it was considered that when the lands to the north of said subdivision were developed the south thirty (30) feet of said lands would be added to Dunwood Road to make a road sixty (60) feet in width, and

WHEREAS, as said Calumet Downs Subdivision has been developed and the lands north thereof have been developed, it appears unnecessary and undesirable to establish said road as a sixty (60) foot road or to maintain it as a thirty (30) foot road and that, therefore, the hereinafter designated portions of Dunwood Road should be vacated and discontinued, and

WHEREAS, the lands affected by such vacation and discontinuance are:

- Lots One (1) and Sixteen (16), Block One (1), Calumet Downs Subdivision, and the unplatted land lying north of and abutting on said Dunwood Road in respect to Dunwood Road between Bell Road on the east and Fairchild Road on the west.
- 3. Lot One (1), Block Three (3), Calumet Downs Subdivision, and the unplatted land lying west of the west terminus of Dunwood Road as shown on the plat of said Calumet Downs Subdivision, in respect to a portion of Dunwood Road lying between Seneca Road on the east and the west boundary of said subdivision on the west.

NOW, THEREFORE, since the public interest requires it, the following portions of the following named street or highway in the Village of Fox Point, Milwaukee County, Wisconsin, are hereby vacated and discontinued.

- Dunwood Road between Bell Road on the East and Fairchild Road on the west.
- 2. Dunwood Road between Fairchild Road on the east and Seneca Road on the west.
- 3. That portion of Dunwood Road bounded on the north by a line parallel with and sixty (60) feet south of the northerly line of that road known as Dunwood Road as described and platted in the Bacon Homesites Addition, a subdivision of lands in the

North East One-quarter (NE1) of Section Seventeen (17), Town Eight (8) North, Range Twenty-two (22) East, Village of Fox Point, Milwaukee County, Wisconsin, and on the south by the north line of Lot One (1) Block Three (3), Calumet Downs Subdivision.
