THIS INDENTURE made this 11th day of May, 1955, between

## WITNESSETH:

Grantor, for itself, its successors and assigns, for and in consideration of One (\$1.00) Dollar and other good and valuable considerations to it paid by the Grantee, the receipt whereof is hereby acknowledged, has granted and conveyed and by these presents does grant and convey unto Grantee, its successors and assigns, an easement for the conducting and carrying away of sanitary sewage by means of an underground sewer, and for the installation, operation, use and necessary repair and maintenance, including reconstruction of such underground sewer, over and across those premises in the village of Fox Point, Milwaukee County, Wisconsin, described as follows:
