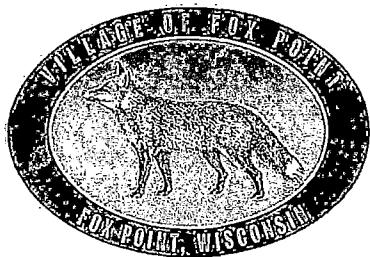



An inspection of the premises located at 8500 N. Fox Croft Lane discloses noncompliance with Codes or Ordinances of the Village of Fox Point as hereinafter listed:

1. Provide backflow protection for all exterior hose bibs and laundry tub faucets.
2. It was noted that several hot wires were hanging from the basement fluorescent light fixture. This situation shall be brought into code compliance.
3. The maximum uniform rise for a step is 8". The service door leading to the garage and the garage service door on the north wall of the garage have excessive rises. These steps shall be brought up to code.
4. Garage receptacle is improperly wired.
5. Provide a code complying outlet for the garage door opener.
6. It appeared that the south foundation wall has structurally failed. It was noted that this wall was approximately 2 to 3 inches out of plumb. Also, the east and west walls were approximately 1 to 2 inches off of plumb in several places. These walls shall be repaired/rebuilt as required by code.

The premises at the above address shall be brought in compliance before there is a change in occupancy. Please notify this office when corrections have been made and a reinspection of the premises for compliance is desired.



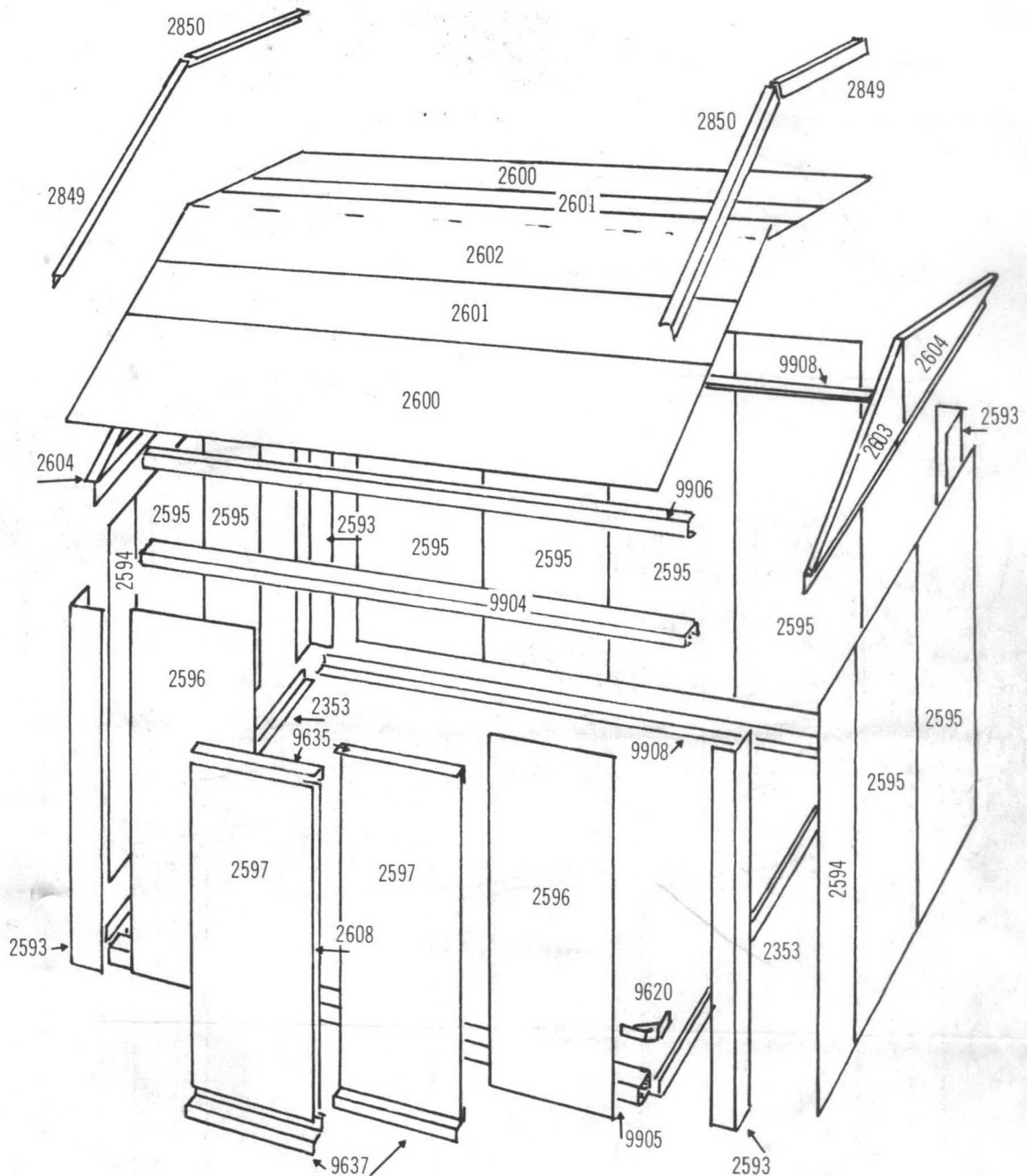

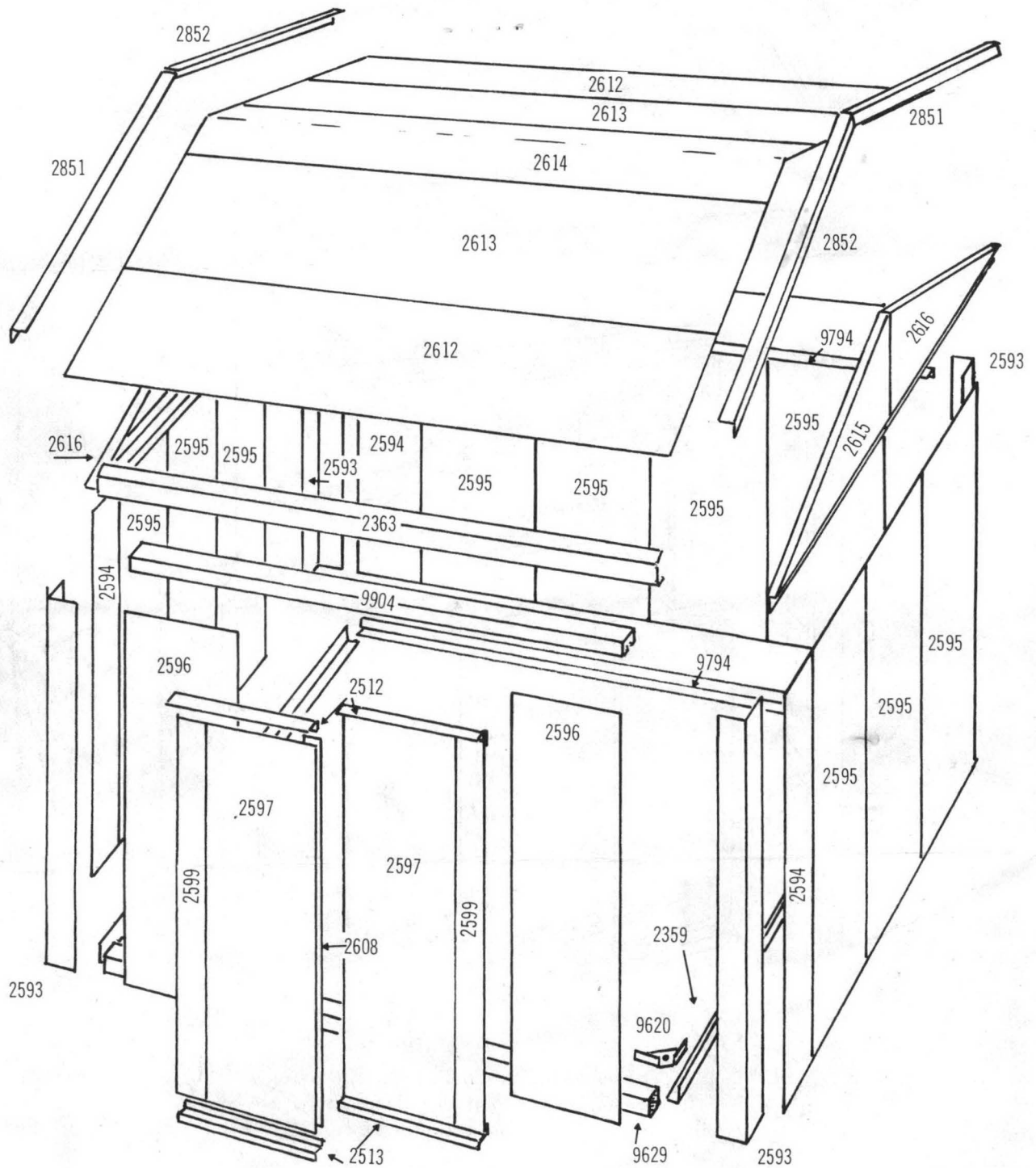
